Topics

CAMRA Ltd.

It is proposed that CAMRA be incorporated by Guarantse not by Share Capital. If shares were issued membership enlargement would be limited, and costly and lengthy proceedures would have to be followed to increase share capital to keep pade with membership. Every member of CAMRA ltd. will be liable for its debts up to the amount of flatfit goes into liquid ation. Normal annual subscriptions will continue to be paid. As there will be no share capital, no profit or dividend will be paid.

A proposed Memorandum of Association sets out the "objects" of CAMRA Ltd. These incorporate the existing aims of CAMRA, and give extra powers to the directors to take any necessary measures to further the objects of CAMRA Ltd., e.g. manufacture of goods, investment, purchase and lease of property. The directors are empowered to carry out any additional activities, which they think likely to further the aims of CAMRA, but any substantial change from the original aims of CAMRA Ltd. will result in considerable litigation on behalf of aggrisved members, and possibly its liquidation.

The internal affairs of CANKA Ltd. Will be regulated by articles of Association. These authorise the appointment of directors to carry out the day to day running of the company, and define the proceedures to be followed by the directors, and by the company in general meeting. These regulations must be strictly adhered to by law.

An annual General Meeting must be called every 12 months, and the necessary proceedure is laid down. These shall deal with accounts, finance, the appointment of directors, and other important business. Extraordinary General Meetings can also be called.

The directors are officers of the company and can be effectively controlled by its members. Certain provisions are written in dealing with the removal or disqualification of directors. on specific events, e.g. their bankruptcy. If the members feel that the directors are acting in a manner detrimental to the aims of CAMRA, there is provision written in for the calling of an ECM for the removal of a director or directors. Further any director or member who acts in a manner detrimental to CAMRA can be removed. If any director or member makes a profit or benefits by priviledged information then the company can claim for such profit, or the value of any benefit recieved.

The Derby Area Good Beer Guide

Camra is unlikely to achieve much lasting success until the brewer's sales figures show that the most popular pubs are those which serve good draught beer. It follows that the production of our own local Good Beer Guide is one of the best ways in which we can help the campaign.

If we produce a local guide it should be as reliable and comprehensive as possible. We should not direct unsuspecting members of the public to pubs which serve real ale badly, nor should we lay ourselves open to justifiable criticism from the regulars of any pub serving excellent real ale, which we didn't happen to know about. We must therefore look at all pubs, and, because we are all fallible, we must not include any pub in a guide purely on the basis of one person's recommendation, or solely on the evidence of how the beer tasted on one particular night.

In view of the very large number of pubs in our area (about 800) it was decided that the only way in which we could hope to achieve these objectives was to invoke the help of all members. This was done quite simply by asking everyone to fill in the 'voting forms' available at each meeting, with the pubs they visit or use regularly, giving their opinion of the quality of the beer. The information provided in this way could then be collated by the Good Beer Guide Sub-Committee, who would investigate the inevitable conflicting ports, and draw up the final selection of pubs.

This system was introduced in June. Since then the GBGS-C members have done a tremendous job, and put in their own votes covering over 400 pubs. Unfortunately we have as yet only received a handful of reports from other branch members.

We want to produce our guide in January/February ie before the National. This gives a very tight schedule: the final selection has to be made; the pubse descriptions and amenities determined; the editorial written; and arrangements made for printing and sales. This will involve the GBGS-C in a lot of work, and give them less time for beer tasting.

We are therefore making a final appeal to all members to get those voting forms in. Everyone must know several pubs well enough to comment on the beer already, and it takes very little effort to go out and visit half a dozen or so new ones. Every report is checked, but no one is going to be criticised for making mistakes, we all do, that's why we want a broad consensus of opinion.

A list of potential local guide entries is now available to members. It shows those for which further votes are required because they ve had favourable comments, but it does not by the large number of pubs for which there have been no votes at all. We need your votes on these too, even if they re keg, it saves someone else checking.

Whether we can compile a guide worth publishing hangs in the balance. We need maximum effort by all members, and those voting forms in as soon as possible, mid-December at the latest.
