Britain's beer drinkers are celebrating a victorious campaign by CAMRA to fight off a legal challenge to the British guest beer law. In August the European Commission announced that it would take action against the

British law, claiming that it discriminated against imports.



The Government has announced a proposed amendment to the guest beer provision. At the moment tenants of national brewers can buy one cask conditioned beer from a supplier of their choice as well as beers from their tied supplier. The proposal extends this to allow one bottle conditioned beer.

Commenting on the proposal CAMRA Campaigns Manager

district declared a local monopoly

Stephen Cox said. "This is a sensible extension of the existing rule. It will offer British and Continental brewers of speciality beers new markets for their products, and it will stimulate the production of these beers in the UK. The new proposal will be workable and it will ensure that the guest beer law remains fair to all brewers."

"The British beer market offers more imported beers than any other European country; British pubs offer the best choice in Europe. The current guest beer law does not discriminate against imports and no-one has produced convincing evidence that it restricts consumer choice or cross border trade. We welcome further improvement in the guest beer law, which can only strengthen the case for retaining it."

The commission have been satisfied by some relatively minor amendments to the legislation which will actually improve consumer choice. "It's time to thank all those who helped in our campaign and to draw a pint of high quality guest beer to celebrate!"

Cask conditioned beer continues to ferment in the cask - real ale and a number of Continental ales and lagers.

Bottle conditioned beer continues to ferment in the bottle - there are a number of British products and a variety of Continental speciality beers. Most of Europe's traditional speciality beers are sold in bottles.

of the glass? New glasses are batch inspected (BS 6001) for capacity by Trading Standards Officers and approved if within the following tolerances.

Glass Tolerance (ml) type Pint Half Brim + 34 ml (6%) + 20 ml (7%) -0 -0

Lined ±17 ml (3%) ±10 ml (3%)

There are only two glass manufacturers still in business in the UK: Dema at Chesterfield and Pilkington at St Helens, and the latter imports a lot of glassware from France. These high-volume plants use modern quality techniques which monitor parameters against a target. If a parameter moves away from the target corrective action can be taken before the tolerance limit is reached, eliminating the need for scrap and rework.

The target - and therefore the average - glass size is 585 ml, being a pint plus half the allowable tolerance. So if you have a brim measure glass brim full you will almost certainly have 17 ml (3%) too much beer, if that is not an alien concept.

"totally unfitted"

A judge has declared a Bass pub "totally unfitted and unsuitable to hold a licence."

The **Granville** in Swadlincote has been the subject of a Crown Court appeal against Derby and South Derbyshire Magistrates' decision to revoke the licence.

The pub, run by a succession of Bass companies and a host of licensees in the past 10 years, has been the centre of violence in the town. Counsel for the police, Mr. Robert Crawford, said Bass had "lamentably failed over many years to protect their licensees and the residents of Swadlincote." he recalled:

- ◆* Doorman Keith Day being brutally beaten with a iron bar and later dying.
- Users of nearby shops being 'seriously frightened' by yobs.
- Shop staff being subjected to abusive language.
- Customers cheering on a broken bottle fight between two women, one of whom lost an eye.
- Licensees fleeing the town in fear of their lives.


Since the pub closed crime in the town has dropped 40%.

A former licensee, still in hiding, installed a panic button, wired to the police station via a dedicated phone line. On the night his doorman was attacked he was threatened with a knife and a shotgun. He hit the button, but Bass had discontinued the line without telling him. The police arrived 15 minutes later following a 999 call. He fled for the safety of his wife and children and

Kimberley Mild, Bitter, Classic and Cellarman's Cask complained that Bass had given him no support.

After the last licensees fled, the pub was broken into, but police could not contact anyone at Bass for three days.

Bass Lease Company's business director, Andrew Thompson. announced £80,000 revamp plans, but the Bench were unimpressed. Judge Brian Appleby said the company wanted to re-open the pub "on purely commercial grounds and not for the benefit of the people of Swadlincote. For many years this terrible place has been a blight on the community of Swadlincote. It is a terrible place with tenant after tenant leaving in terror. why is Bass suddenly doing something now?"

The company has not admitted making a mistake, he added. "Bass sat back and didn't care and just put in one licensee after another. That's the company you represent," he told Thompson. "Bass must have known the situation through its district managers. They must have been aware of the disgraceful way the premises were being run and the consequent damage and injury offered to people in the town centre."

At the end of the two-day hearing Judge Appleby awarded costs against the company and said, "I consider this appeal has been totally devoid of merit."

After the case Thompson said, "We have presented our case and lost our case. Now we will have to decide the future of the premises."



Morning after drivers are not as likely to fail breath tests as was supposed. The Lancet has reported

Dr. Neil Wright, researcher at Leicester University's Department of Psychiatry, measured morning breathalcohol levels of 58 male drinkers. Thirty of them had consumed more than 20 units. yet none exceeded the drink-drive limit of 35 micrograms per millilitre, including 44 who felt hungover and unfit to

Twenty-three were rated light to moderate drinkers (less than 29 units per week) while the rest were rated heavy or very heavy (more than 29). Wright says

fasting man in laboratories and showed alcohol still detectable eight hours after drinking six units. This was misleading, because most social drinkers consume food as well, which inhibits the absorption of alcohol. And the heavy, habitual drinkers showed 'raised alcohol elimination due to regular heavy drinking."

Wright recorded wide variations between individuals. One man logged 26 mg/100 ml after drinking 14 units in 4.5 hours the night before, whilst another had zero breath concentration after consuming 23 units in 5 hours.

We're buying AIR!

Drinkers are buying nothing - for a million pounds a day.

Pints are getting rarer - and it's nothing to do with the EU. A CAMRA survey reveals 8 out of 10 'pints' are not pints at all, but something less. CAMRA asked every Trading Standards department in Britain for details of their surveys of local pubs and things are worse than anyone imagined.

- 80% of pubs sold short measure pints.
- * at least a quarter of pints were below the industry guideline of 95% of a pint.
- ♠™ Trading Standard officers are not taking action because of legal uncertainty.
- There is widespread support for the introduction of lined glasses.

The Brewers and Licensed Retailers Association guideline says beer and froth should be at least 95% of a pint (19 fluid ounces), but this seems to be regarded as a maximum by unscrupulous retailers. J. H. Potts, Chief Trading Standards Officer for Lancs. County Council, says "In practice, many pubs in Lancashire have, perhaps, changed from line-measure to brim measure in order to take advantage of the 'legalised short measure' outlined in the industry code."

Paul Bostock of the Notts. Trading Standards office says the BRLA 'guidance notes are not enforceable in law and therefore are of no use. ... This Authority along with many others have now ceased positive enforcement in this area of trade." The government lost us this consumer protection when they revoked Section 43 of the 1985 Weights and Measures Act in 1994. This "has resulted in the farcical situation that it is the customer who now has the obligation to ensure he receives a full pint of beer. One of the reasons put forward for not implementing the legislation was that the cost of changing all brim measures to lined measures would be exorbitant. Since that decision how many brim measures have been replaced due to Natural wastage?", asks a Carmarthen-

Labour's consumer affairs spokesman Nigel Griffiths says a Labour government will restore Section 43. The brewing industry responded with the outcry that restocking with lined glasses will cost £19 million. They are too modest to mention how much they have saved since 1994 by selling people fresh air when they ask for beer, then pocketing the VAT and duty.

PS How come Banks's and Camerons, who have a lined glass policy, sell their beer cheaper than their local competitors who use brim measures? The Wolverhampton and Dudley Brewery who own both is a highly profitable company. It couldn't be that the industry is scaremongering again, could it?

The facts - supplied by Banks's in March this year and CAMRA's prices survey in July LAST year sink the "costs too much" argument once and for all!
